-----CAMPAIGN REPORTING REQUIREMENTS-----

CANDIDATE'S CAMPAIGN COMMITTEES, POLITICAL ACTION COMMITTEES, AND ALL CANDIDATES, WHETHER SUCCESSFUL OR NOT, MUST FILE A STATEMENT OF CAMPAIGN RECEIPTS NO LATER THAN OCTOBER 30, 2018, AND A STATEMENT OF RECEIPTS AND EXPENDITURES NO LATER THAN NOVEMBER 16, 2018. FEDERAL, STATEWIDE AND STATE LEGISLATIVE CANDIDATES MUST FILE WITH THE SECRETARY OF STATE. COUNTY, MUNICIPAL AND SCHOOL DISTRICT CANDIDATES MUST FILE WITH THE COUNTY CLERK,. W.S. 22-25-105 THRU 22-25-109. A CANDIDATE WHO FAILS TO FILE FULL AND COMPLETE ITEMIZED STATEMENTS WILL BE SUBJECT TO PENALTIES PRESCRIBED IN W.S. 22-25-108.

-----VOTING ASSISTANCE-----

IF YOU REQUIRE ASSISTANCE TO VOTE BY REASON OF BLINDNESS, DISABILITY OR INABILITY TO READ OR WRITE, YOU MAY BE GIVEN ASSISTANCE BY A PERSON OF YOUR CHOICE. ALSO, IF YOU HAVE QUESTIONS REGARDING THE ACCESSIBILITY OF YOUR POLLING PLACE, PLEASE CONTACT YOUR COUNTY CLERK.

-----ABSENTEE VOTERS-----

A QUALIFIED ELECTOR MAY APPLY FOR AN ABSENTEE BALLOT AT ANY TIME DURING THE CALENDAR YEAR IN WHICH THE ELECTION IS HELD, BUT NOT ON ELECTION DAY.
